

PRE-REGISTRATION INFORMATION

Pre-registration of Fair exhibits is available until August 1, or on-site registration on dates and times stated in the General Rules Section or the individual departments in the Premium Catalog. An exhibitor can do both pre-registration and on-site registration if necessary. Pre-registration is not mandatory but is encouraged. The \$2.00 exhibitor fee will be waived if the entries are received by August 1.

The registration form can be printed from our Premium book page on our web site at www.southmountainfair.com or the form can be found in our printed Premium book. **A separate form must be used for each exhibitor.** An exhibitor may send in as many different pre-registration forms as necessary prior to the deadline. A confirmation will be sent for all forms received. Other registration forms are used to register livestock. They can be found on the web site or in the Premium book. Check the livestock departments for details.

Pre-registration can be done in phases if necessary. So, if you send a registration form in May and then in July you decide that you want to enter something else you just need to send another registration form for the new exhibits.

If you decide not to pre-register or if you missed the August 1 deadline, you can still register your exhibits on-site on Sunday and Monday before the start of the Fair as was done in prior years. Refer to the General Rules Section or to the individual departments for exhibit registration and entry dates and times.

If you have trouble using the form you may simply send an email which includes all the information on the form.

By entering exhibits in the Fair you consent to having pictures taken of the exhibits and used for advertising purposes on the Fair web site and in other advertising venues.

Directions for completing the Entry Form:

1. Fill in personal information at the top: Name, current date, address, telephone number, email address and whether this exhibitor is entering as a junior or senior/open. All entries listed must be for the exhibitor listed on this form. **Use separate forms for each exhibitor.**
2. **This form should NOT be used to register any livestock. The appropriate livestock form must be filled out and sent to the Department chairperson.**
3. Find the correct Department, Section, and Class for your item, using the Premium Book.
4. After entering the Department, Section, and Class, fill in the class description listed in the Premium Book.
5. If you have any questions about filling out your entry form, please call the appropriate department chairperson listed in the Premium Book.
6. Please mail the form to the address listed below, or email the information to smfjvi@yahoo.com by August 1.
7. All exhibitors should read the pre-registration information page.
8. By entering exhibits in the Fair you consent to having pictures taken of the exhibits and used for advertising purposes on the Fair web site and in other advertising venues.
